



RESOLUTION NO. 1628

A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY OF CIBOLO'S GENERAL ELECTION HELD ON NOVEMBER 8, 2022.

WHEREAS, the City Council of the City of Cibolo, Texas (the "City") called an election to be held in the City on Tuesday, November 8, 2022, on the RACES hereinafter stated; and

WHEREAS, the City Council has investigated all matters pertaining to this election, including the ordering, giving notice, election officers, holding, and returns thereof; and

WHEREAS, the election officers who held said election have duly made the returns of the result thereof and said returns have been duly delivered to the City Council.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CIBOLO, TEXAS THAT:

SECTION 1. COMPLIANCE WITH LAW. The City Council officially finds and determines that said election was duly ordered; proper notice of said election was duly given; proper election officers were duly appointed prior to said election; said election was duly held; the City has complied with the Federal Voting Rights Act and the Texas Election Code; due returns of the result of said election have been made and delivered; and the City Council has duly canvassed said returns, all in accordance with the law and the Ordinance calling the election.

SECTION 3. CANVASS OF ELECTION RETURNS. The City Council officially finds and determines that the following votes were cast at said election on the submitted RACES & PROPOSITIONS by the resident, qualified electors of the City who voted at the election:

SECTION 4. DECLARING RESULTS OF ELECTION. The City Council further officially finds, determines, and declares the result of Council Member District 2, 3, and 7 elections to be received favorable majority votes in all respects and have carried. The Mayoral election will be called into a runoff election due to no candidate receiving a majority, meaning more than fifty percent of the vote, in accordance with City Charter Sec. 5.04. – Official results.
